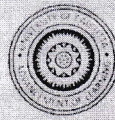

Moreover please note that these registered students shall be allowed to undertake their 1<sup>st</sup> Semester examination along with their 3<sup>rd</sup> semester examination. It is needless to say the students must otherwise qualify to undertake such examination in terms of the University Regulation by fulfilling the eligibility criteria including as regards required attendance.
